



## DAWN FARM RESIDENTIAL FEE AGREEMENT

Dawn Farm provides comprehensive residential services. This Fee Agreement covers basic services for

\_\_\_\_\_, to include:

- Room and board
- Group and individual therapy
- Initial medical office visit (Does not include prescriptions, lab work or emergency care)
- Supervised work therapy
- Addiction education
- Recreation, exercise and arts and crafts
- Transportation to AA meetings, and local medical and legal appointments
- Family Clinical Services
- Aftercare and follow-up services
- Vocational referral (as needed)
- GED tutoring
- Transitional Housing referral

This Fee Agreement acknowledges a flat per diem fee of \$150.00 for the above-noted services and the expected length of stay is at least 90 days. This fee is generously subsidized by community donations in order to make it more affordable.

A non-refundable \$1,050.00 Admission Fee is included in the first payment. If a resident leaves treatment in the first 7 days, the cost is \$1,050.00. After 7 days the bill accrues at the bed/day cost (e.g., 21 days at \$150.00 would cost \$3,150.00). Billing will begin on the date that the resident enters Dawn Farm services (Spera or a residential treatment site). In the event a client is unable to reside in our facility (e.g., hospitalization or incarceration), fees will continue to accrue to guarantee bed availability when they are ready to return. We can discharge the client upon request, but they will need to go through the readmission process when they are ready to return.

If a resident requires psychiatric services, fees are as follows: \$300 for the initial psychiatric evaluation and \$50 per 20 minutes for medication reviews. Psychiatric services are provided upon request, or as needed. A psychiatric evaluation by our psychiatrist is required if the client is currently prescribed a psychotropic medication, has attempted suicide in the last 12 months, or has received inpatient psychiatric care in the last 12 months.

Dawn Farm bills one month in advance for services, and expects payment upon receipt. Any prepaid treatment service dates, not utilized, will be refunded by Dawn Farm. In addition, residential clients who move into our transitional housing are required to pay a full month's rent in advance before he or she moves in.

It is understood that non-payment for services will cause services to be discontinued.

The undersigned have reviewed and agree to abide by this agreement.
